## **Independent Auditors' Report**

### ***Opinion***

We have audited the financial statements of The Hippocratic Cancer Research Foundation, Inc. (the "Foundation"), which comprise the statement of assets and net assets – cash basis as of December 31, 2024, and the related statement of support, revenues and expenses and changes in net assets – cash basis for the year then ended, and the related notes to the financial statements (collectively referred to as the "financial statements").

In our opinion, the accompanying financial statements present fairly, in all material respects, the assets and net assets of The Hippocratic Cancer Research Foundation, Inc. as of December 31, 2024, and its support, revenue, and expenses for the year then ended in accordance with the cash basis of accounting, as described in Note 2.

### ***Basis for Opinion***

The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 2, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

### NOTE 1 - NATURE OF OPERATIONS

The Hippocratic Cancer Research Foundation, Inc. (the “Foundation”) is an Illinois not-for-profit organization that was formed in December 2014. Its mission is to find and implement new treatments for cancer patients, by promoting and supporting breakthrough cancer research. The Foundation operates to raise funds that can support translational research studies at the Robert H. Lurie Comprehensive Cancer Center of Northwestern University.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### *BASIS OF PRESENTATION*

The accompanying financial statements have been prepared on the cash basis of accounting; consequently, revenues are recognized when received rather than when earned, and expenses and purchases of assets are recognized when cash is disbursed rather than when the obligation is incurred. That basis differs from accounting principles generally accepted in the United States of America primarily because the Foundation has not recognized asset and liability balances, and the related effects on net assets, of accounts receivable from donors and of accounts payable to vendors.

#### *CONTRIBUTIONS*

All unconditional contributions received are recorded at fair value and are considered to be available for use without donor restrictions unless specifically restricted by the donor. Amounts received that are designated for future periods or restricted by the donor for specific purposes are reported as support with donor restrictions that increase the net asset class. When the restriction expires, that is when a stipulated time restriction ends or purpose restriction is accomplished, net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statement of support, revenues and expenses and changes in net assets – cash basis as net assets released from donor restrictions. Contributions that are subject to donor-imposed restrictions that are met in the same year as the contributions are made are recognized and reported as unrestricted support and included in changes in net assets without donor restrictions.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### *CLASSES OF NET ASSETS*

The accounts of the Foundation are maintained in accordance with the principles of fund accounting, whereby resources are classified for accounting and reporting purposes into net assets established according to their nature and purposes.

#### *Net Assets Without Donor Restrictions*

Represents the portion of expendable funds that are available for the daily operations of the Foundation, which are not limited by donor restriction on use.

#### *Net Assets With Donor Restrictions*

Consists of donor-restricted contributions received with specific time or purpose restrictions. Upon satisfaction of time or purpose restrictions, net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statement of support, revenues and expenses and changes in net assets – cash basis as net assets released from donor restrictions.

Consists also of contributions that are subject to donor-imposed restrictions of the gift instruments that require the principal be invested in perpetuity, and that income only be utilized in the operations of the Foundation. The Foundation had no net assets with donor restrictions at December 31, 2024.

#### *INCOME TAXES*

The Foundation is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code. In addition, the Foundation has been determined by the Internal Revenue Service not to be a “private foundation” within the meaning of Section 509(a) of the Internal Revenue Code. Therefore, the Foundation has made no provision for income taxes in the accompanying financial statements.

The Foundation evaluates all significant tax positions. The Foundation does not believe that it has taken any tax positions that would require the recording of any additional tax liability, nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. If the Foundation were to incur an income tax liability in the future, the interest on any tax liability would be reported as interest expense and penalties on any income tax paid would be reported as income taxes. The Foundation’s income tax returns are subject to examination by the appropriate taxing jurisdictions. There are currently no examinations pending or in progress.
